### 1. Property

### 2. Rights and Restrictions

(a) Seller warrants it either expressly owns the property or has the full legal right and authority to broker this property for the Writer(s).

(b) For valuable consideration of \$ 15ea., Buyer will be sent ONE copy of the Script(s) by Seller to evaluate for theatrical production consideration. The ONE copy of the Script(s) may be kept for evaluation and archival purposes only by the Buyer. Any future production of the Script(s) by Buyer, regardless of version date of the Script(s), may only be done with rights assigned through a binding contract with Seller. No advertising or indication of performance of any kind by Buyer may be made before such binding contract is entered into.

(c) Buyer acknowledges the Script(s) is protected by copyright laws and conventions. It is an infringement of copyright law to give a performance or reading of the Script(s) or excerpt any portion without the prior consent of Seller. It is also a violation of copyright law to copy part or all of the Script(s) by any means, including but not limited to, any mechanical means, electronic means, typewriter, photocopy, audiotape, videotape, and transcription. Violation of copyright law is enforceable by Federal law and the laws of interstate and intrastate commerce.

(d) Furthermore, Buyer's knowledge of parties outside this Agreement violating any copyright laws and/or conventions pertaining to the Script(s) must be made known to Seller, or Buyer may be held liable.

**3. Changes to Agreement**

The provisions of this Agreement may be waived, altered, amended or repealed in whole or in part only with the prior written consent of all parties to the Agreement. Any waiver of any part of this Agreement does not invalidate any other part of the Agreement.

**4. Breach of Agreement**

This Agreement shall be governed by the laws of the State of California. Any controversy or claim arising out of or relating to this Agreement or any breach of it, by either party, may be settled at the sole discretion of Seller by arbitration according to the Rules of the American Arbitration Association, and judgment upon the award rendered by the arbitrators may be entered in any court having jurisdiction thereof. Seller shall be entitled to reimbursement for costs and reasonable attorneys' fees by Buyer.
